- If you did not maintain a U.S. tax home (unless you worked in a designated Combat Zone) and were either physically present in a foreign country for at least 330 days during a consecutive 365 day period that includes the taxable year, or were a bona fide resident of a foreign country the entire year, you may elect to exclude up to \$126,500 of your foreign earned income
- Provide details of foreign taxes withheld and paid along with foreign tax returns to substantiate credits or deductions
